**NOTICE OF ADJUDICATION AND PUBLIC COMMENT HEARING  
EFSB 21-04/D.P.U. 21-149 Eversource Energy and National Grid**

Notice is hereby given that, pursuant to G.L. c. 164, §§ 69J, 72, NSTAR Electric Company d/b/a Eversource Energy (“Eversource”), located at 247 Station Drive, Westwood, Massachusetts 02090, and New England Power Company d/b/a National Grid (“National Grid”), located at 40 Sylvan Road, Waltham, Massachusetts, 02451 (together, the “Companies”), have filed two related petitions with the Energy Facilities Siting Board (“Siting Board”) and the Department of Public Utilities (“Department”) in connection with the Companies’ proposal to construct, operate and maintain an approximately 12.1-mile 115-kilovolt (“kV”) primarily overhead electric transmission line along existing rights-of-way (“ROW”) between Eversource’s Industrial Park Tap in Acushnet, Massachusetts, and National Grid’s Bell Rock Substation in Fall River, Massachusetts (the “New Line”). The New Line is an extension of Eversource’s existing Line 114 and will traverse 7.9 miles in Acushnet, New Bedford and Dartmouth, which will be owned and operated by Eversource, and 4.2 miles in Fall River, which will be owned and operated by National Grid. In conjunction with the New Line, National Grid will be installing additional equipment at the Bell Rock Substation in Fall River. Also, Eversource will be adding protection and control relay equipment within the control houses at its Tremont Substation in Wareham and its Acushnet Substation in Acushnet (the “Station Work”). The New Line, together with the Station Work, is referred to as the Acushnet-to-Fall River Reliability Project, or the “Project.”

**The Siting Board will conduct a remote public comment hearing regarding the Project using Zoom videoconferencing at 7:00 p.m. on Monday, April 25, 2022.** Attendees can join by clicking (or entering) the following link <https://us06web.zoom.us/j/81610084315> from a computer, smartphone, or tablet. Additional commenters may be allowed during the public comment hearing, at the discretion of the Presiding Officer.

The Siting Board will accept written comments on the Project. Written comments will be most useful to the Siting Board if submitted by **Monday, May 9, 2022**.

Persons or groups who wish to be involved in the Siting Board proceeding beyond providing comments at the public comment hearing or submitting written comments may seek either to intervene as a party or to participate as a limited participant. A petition to intervene or participate must be filed with the Siting Board in electronic format, by email or email attachment, to

Simultaneous English-to-Spanish/Portuguese/Portuguese-Creole interpretation will be provided. All attendees should select their preferred language to hear the Interpreter translate into that language. Press the globe icon  and then choose the desired language.

### **Public Comment Hearing**

At the public comment hearing, the Companies will present an overview of the Project. Public officials and members of the public will have an opportunity to ask questions and make comments about the proposed Project. The public comment hearing will be transcribed by a court reporter. A recording of the public comment hearing will be posted to the [Department's YouTube](#) channel after the hearing.

### **Intervention and Participation**

Persons or groups who wish to be involved in the Siting Board proceeding beyond providing comments at the public comment hearing or submitting written comments may seek either to intervene as a party or to participate as a limited participant. Intervention as a party allows the person or group to participate fully in the evidentiary phase of the proceeding, including the right to participate in evidentiary hearings and to appeal a final decision. A limited participant would receive documents in the proceeding and may file a brief as well as file written comments and/or present oral comments regarding the Tentative Decision to the Siting Board.

Any person wishing to intervene as a party or to participate as a limited participant in this proceeding must file a written petition with the Presiding Officer (see Filing Instructions below). A petition to intervene or be a limited participant must satisfy the timing and substantive requirements of 980 CMR 1.00, the Siting Board's procedural rules, which can be found on the Siting Board's website at: <https://www.mass.gov/doc/980-cmr-1-rules-for-the-conduct-of-adjudicatory-proceedings/download>. To be allowed, a petition to intervene filed pursuant to 980 CMR 1.05 must demonstrate that the petitioner may be substantially and specifically affected by this proceeding.

### **Filing Instructions**

Written comments on the Project, or a petition to intervene or participate as a limited participant in this proceeding, must be filed in two places:


First, the petition to intervene or participate, and comments, must be filed with the Siting Board in electronic format, by email or email attachment to [dpu.efiling@mass.gov](mailto:dpu.efiling@mass.gov); and to [andre.gibeau@mass.gov](mailto:andre.gibeau@mass.gov) no later than the close of business on **Monday, May 9, 2022**. The text of the e-mail must specify: (1) the docket number of the proceeding (EFSB 21-04/D.P.U. 21-149); (2) the name of the person or entity submitting the filing; and (3) a brief description of the document. The electronic filing should also include the name, title, and telephone number of a person to contact in the event of questions about the filing.

**Siting Board Jurisdiction**

Under G.L. c. 164, §§ 69H, 69J, the Siting Board will review the Companies’ filing to determine whether the Project would provide a reliable energy supply with a minimum impact on the environment at the lowest possible cost. Under G.L. c. 164, § 72, the Siting Board will determine whether the proposed Project is necessary, serves the public convenience, and is consistent with the public interest.

**The Companies’ Proposed Transmission Line Route**

The Companies maintain that the Project is needed to ensure the reliability of the electric transmission system in Southeastern Massachusetts and Rhode Island.

The Companies propose to construct the New Line on a new set of 118 self-weathering or galvanized steel H-frame and monopole structures that are generally directly embedded into the ground. Structures located at angle points, dead-end structures, and certain select structure locations within the ROW will be installed on concrete caisson foundations. Construction will be adjacent to an existing 115 kV transmission line within an existing transmission ROW that varies from 150- to 210-feet in width. To accommodate the new line in Fall River, the cleared width of the

existing ROW will be expanded by approximately 62-feet on the south side of the National Grid ROW. The New Line is to be constructed predominantly overhead, except for the construction of two short sections of underground cable (a total of approximately 600 linear feet) to be installed to avoid multiple overhead line crossings at the Industrial Park Tap in Acushnet and at the High Hill Switching Station in Dartmouth. There will be no changes to the existing 115-kV transmission lines or structures located within the existing ROW. Ownership of the New Line will transition from Eversource to National Grid at the Dartmouth/Fall River municipal border.

### **Station Work**

To accommodate installation of the New Line along the Companies' Proposed Route, Eversource and National Grid will be making upgrades at the Bell Rock, Tremont, and Acushnet Substations. These upgrades include installation of equipment at the Bell Rock Substation to complete the termination for the New Line. Work at Tremont and Acushnet Substations will consist of limited underground conduit installation and/or be contained within the existing station control buildings. No fence line expansion or removal of existing equipment is required to accommodate the New Line.
